- New COVID Grant Funding Committee (Angie Dobbins) confirmed (10 mins)

- New faculty communication (Katie Thomas)- confirmed
 - Earlier this summer Cali reached out to deans asking them to get information for faculty starting in the fall or for those who came to ISU since the last New Faculty Orientation. Letter sent June 23, 2021
 - Trying to streamline the new hire process
 - Deans encouraged to get New Hire completed by July 26, 2021 so faculty have their emails activated by the time they start on campus

- Report out from action plan due November 1, 2021.
- Every year we are asking for the annual report on May 1, 2021.
- Report outs will be included on all action plans. Quintiling not required for annual reports but for every five years.
- Special course fee proposal Chris Owens/Chris Sanford
 - Council of Deans concerned about the high fee. Working professionals might be interested in getting some special training to help them in listening and spoken language. This is for Listening and Spoken Language Certificate. We need a streamlined process to get professionals trained to help kids. Total cost of the program was \$24,000-\$26,000. It is high relative to other programs to be completed in a conservatie and sustained way. This was modeled after Christie Blaizer and her work in Minnesota regarding this same certificate type.
 - Career-ladder certificate for Listening and Spoken Language Certificate.
- Cloud Computing proposal Debbie Ronneberg
 - Submitted as specialized certification initially to the Council of Deans, but the OSBE said it did not meet
 the criteria of a specialized certificate because it would require students to have a prior certificate or
 degree.
 - This is through Amazon Web Solutions, COT does not want to require students to have a prior certificate or degree, so it is being changed to Basic Technical Certificate. All five courses are online, \$300 per credit and will lead to Amazon Badges.
 - Approved to send forward to Administrative Council and Leadership Council.

 - Working Group looking at Policy III.B before approval at state level
 - ISU referencing current stateboard policy
