- VII. ANNOUNCEMENTS AND CORRESPONDENCE
  - a. Bengal Giving Day 2026, Levi Gribas and Daniel Moore
    - i. Levi Gribas and Daniel Moore shared that Bengal Giving Day will take place on March 10th and 11th, 2026. This year, there will be a strong push to ensure students are aware of and involved in the event. While donors are responsible for making contributions, the direct impact of Bengal Giving Day benefits students. The 1,901-minute fundraiser blitz will begin at 9:00 AM on March 10th and conclude at 4:41 PM on March 11th. A new fundraising platform, GiveCampus, will be used this year. Colleges will be the primary units with direct landing pages, though departmental and club-specific links are available upon request. Challenge and matching gifts are available for donations of \$500 or more. There will be workshops focused on maximizing fundraising efforts for Bengal Giving Day will be offered. One workshop will take place at 10:00 AM on Wednesday, February 18th. Attendance at these workshops is strongly encouraged. ASISU can support Bengal Giving Day by promoting the event. Suggested efforts include attending workshops, sharing Bengal Giving Day information and posts on social media, reaching out regarding challenge gifts, and seeking referrals. A live event will be held in the Student Union Building and will align with ongoing student activities. Planned events include cornhole games, students versus faculty competitions, and a prize awarded after 100 donations. Students can also participate in a "Find the Bengal" activity, with the prize being a donation made on their behalf to the department of their choice. A demonstration of the Bengal Giving Day website was provided, including how funds are accessed and how department- or club-specific links function. Bengal Giving Day is a crowdfunding event designed to raise money for specific areas on campus or scholarship funds.

All funds raised directly support Idaho State University and benefit students. Student clubs are still able to sign up and will need an "About" section and a photo to participate.

- b. ISU Dance Company (New Club) – Blue Hill and Val Davids, Student Leadership and Engagement Center Coordinator
  - i. Val Davids shared that the ISU Dance Company, formerly known as Dance On, is working to become an active club again on campus. The ISU dance program has been significantly reduced over the past several years, and this club aims to help fill that gap by providing dance opportunities for students. The club plans to offer dance classes for students, host performances both on campus and in the community, and organize social events. Currently, the club roster includes 12 students. For this semester, the focus will be on offering a variety of technique classes and dance styles to encourage participation from both new and continuing dancers. The club seeks to provide students with an outlet to pursue their passion for dance regardless of experience level. One long-term goal is to host a dance concert, an event that was previously organized by the dance department but is no longer offered. The club hopes to bring dance back to campus in a larger and more visible way. For students interested in deeper involvement, the club is considering a master class weekend as a fundraiser for the concert. This event would include instructors from the local area. Tara Young, Chair of the Theatre and Dance Department, serves as the club's advisor.
