Director of Student Affairs, Austin Job Director Job shared that he has successfully secured approval for the magnesium supplement initiative from three key sources: the Head of the Counseling and Testing Center, the Physician Assistant at the Health Center, and the Director of the Wellness Center. Before distributing the supplements, students will be advised to consult the Health Center if they have any concerns, and they will be clearly warned not to take the supplement if they are pregnant or have liver failure. It has also been confirmed that the magnesium will not interact with other commonly used medications. With a \$1,000 budget, the initiative will be able to provide a 14-day supply to approximately 480 students. An informational slip on sleep hygiene will also be distributed alongside the supplements to encourage healthy sleep practices.
