- VI. CHAIRS REPORT
 - a. Senator Saunders shared that today, we will approve the initial and new club deposits for the 2025-2026 academic year. For new clubs, there is \$5,000 available in total funding for the year, with an initial deposit total amount for the year of \$6,000. His recommendations for each new club as well as initial deposit amounts is to be between \$200 and \$400. Senator Saunders also shared that ASISU travel amounts for graduate and undergraduate students will remain the same as last year. There is a meeting planned with the Provost and Graduate Office to review reporting expectations and other conditions outlined in the previously signed Memorandum of Understanding. If these expectations are not met, travel funding will be discontinued through those offices.
 - i. Theresa Brissette added that funds allocated to students for traveling to and attending conferences are governed by a Memorandum of Understanding. The agreement includes an end-of-year recap and monthly audit reports, but the monthly reports have not been consistently submitted. We are working to ensure this requirement is reinstated and to clarify what information is needed monthly regarding the use of these funds. These offices receive \$13,000 and \$20,000 respectively, and we need to strengthen these relationships moving forward.
