- VIII. PRESIDENTS REPORT
 - a. President Halter shared that he has been meeting with a company in Idaho Falls, Biologic, in collaboration with the campus Sustainability Department to organize a Sustainability Summit scheduled for March. Additionally, he is working with Housing and Ambassador leaders to coordinate a Student Leader Social on October 2nd, with more event details to be shared as the date approaches. He is also collaborating with the Student Involvement Committee to organize the September 20th tailgate and the September 27th watch party.

IX. CHAIR/COMMITTEE REPORTS

- a. Senate Pro Tempore Committee, Senator Vargas Barvosa
 - i. Senator Vargas Barvosa shared that he has been working with the entire Senate to ensure everyone is fulfilling their duties. He also provided updates shared during President's Cabinet by executive members. The Idaho Falls campus has had a great start to the year, thanks to the support of Vice President Taylor. Director Burelle has updated and revised Benny's Funding Request Form for the year. Senator Vargas Barvosa has also been working with Director Kankolongo to better highlight line items, clubs, and other on-campus resources available to students.

- b. Finance Committee, Senator Saunders
 - i. Senator Saunders shared that during the Finance Committee meeting, they discussed and set the Initial and New Club funding amounts for the academic year. New Club funding has been set at \$250 per club, providing funding for up to 20 new clubs. The Initial Deposit amount has been set at \$300 per club, allowing 20 clubs to receive initial deposits. The Internal Funding Request being covered tonight was approved in Finance. This request allocates \$300 for the September tailgates to cover the cost of drinks and face painting supplies, in collaboration with the Cosmetology Program. Additionally, Senator Saunders will be meeting with both the Graduate School and the Provost's Office to review guidelines and expectations for graduate and undergraduate travel funding.
- c. Senate Rules and Appointment's Committee, Senator Smith
 - i. Senator Smith shared that the committee met today and discussed the possibility of implementing a rule that would prevent the suspension of bylaws. They reviewed what the implementation process might look like and how the rule would function in practice. The committee also discussed the potential of reintroducing a Judicial Branch into the ASISU system.

 - i. Senator Van Metre shared that the committee met yesterday and discussed hiring a DJ for the tailgates. Due to contracting issues, the committee is moving forward with the plan to find a DJ who already has a contract set up with the university.
