I wanted to make some comments on the grievance policy. I know we're going to be discussing this later, so I will keep my comments general and won't address the specific text of the proposed policy.

- (1) First, I note that President Satterlee has the right to simply write whatever policy he wants. So far, he has chosen not to do this, and he is instead continuing to engage with us. Most of the faculty I have spoken with are aware of this and appreciate that. That's a good thing.
- (2) Second, I wanted to emphasize how important it is that we get this right. There are many faculty here at ISU who are not OK, and there are faculty who feel mistreated. I know quite a few who don't really want to come to work because of the environment here. I hear the phrase "teach and go home" a lot. We need to fix that.



- (3) I think it is completely within the realm of possibility that we can get this right. ISU has gotten off of AAUP sanctions and it has passed a Constitution. I think we can get to a grievance policy that most of us can be comfortable with.
- (4) Lastly, my understanding is that we are not going to vote on this policy today. I know there are a number of faculty, who are both within and outside of the Faculty Senate, who have thoughts and ideas on this. It's my understanding that Roberts Rules allow for the Chair to recognize people who are not currently in the Senate to speak, if the Chair so choses. My preference is that we let President Satterlee put forward his proposed text, and then we discuss it.

6) President's Update- Kevin Satterlee

7) Guests-

- a) President Kevin Satterlee
 - i) Grievance Policy
 - (1) Satterlee feels there are underlying concerns that are manifesting in the grievance policy that are not so much about the Grievance policy but are more about fear/concerns/frustrations of the faculty
 - (a) Satterlee explained to the faculty his concerns about why the faculty are afraid of repercussions
 - (b) He feels that is something we definitely need to address
 - (c) We need to address the untrusting atmosphere of the faculty towards the bureaucracy that draws the line between the faculty and the President and why that atmosphere is full of distrust.
 - (d) Satterlee suggested the Faculty Senate choose the version of the Grievance policy they like and we approve that one, with an expiration date of 1-2 years
 - (i) He feels this may help build trust between faculty and administration
 - (2) Beasterfield commented on section IV. C
 - (a) Feels the wordsmithing contradicts itself
 - (b) Carr responded that the words "in consultation with," clear up the contradiction
 - (3) Baxter commented that his issue with the Grievance policy is not about trust from his perspective, but about process
 - (a) Baxter recommended to remove the "ex-officio," language in connection with the Provost and HR in the grievance process
 - (4) Bagley would welcome a discussion about trust and feels it needs to be explored(a) Feels that there could be repercussions amongst faculty as well as administration
 - (5) Delehanty feels the topic of trust is astute and we definitely need to have a discussion regarding this
 - (a) Feels it is a big mistake to make HR and/or the Provost ex-officio members of the grievance panel
 - (6) Stoutenborough also objects to the use of the term, "ex-officio"
 - (a) Suggested that we remove that term altogether
 - (i) The idea is that HR and the Provost are available if needed, but will not be sitting in on the grievance deliberations
 - (7) Dale suggested that we that we accept Satterlee's suggestion that we use the Grievance Policy that Senate approved several months ago and use it with an expiration date.
 - (a) Mentioned that this seems like an extremely generous offer
 - (8) Kirkpatrick found the copy that had been modified by Faculty Senate
 - (a) We will get that version out to the senators for review
 - (9) Baxter said it would be a shame to adopt a version with an expiration date, if we can agree to adopt a version that we can all agree on without an expiration date.
 - (10) Bagley wants to remove the ex-officio language and specify that HR and the Provost cannot vote and not approve a policy with an expiration date





ACTION- Bagley motioned to have the executive committee in consultation with President Satterlee, fix the wordage on the current draft of the policy as prescribed by the faculty senate by removing "ex-officio," in conjunction with HR and the Provost and specify that they cannot vote. This version will then be reviewed and voted upon by Faculty Senate.

Cravens seconded Discussion on the motion took place Motion Carried with 23 yes's, 1 abstention, and 1 no

- ii) Satterlee pitched this idea: Should we take the concept of the role of Faculty Ombuds and elevate it. Invest in an office of faculty ombuds and give it a budget and give those in the office, training.
 - (1) Satterlee asked if that seems like a helpful idea to the faculty.
 - (a) The faculty gave positive feedback in response to this idea

 - i) Per Stacey Marshall
 - (1) We are preparing for our annual Be a Bengal awards for 2021! We are hoping to have a reception on March 28 (if we are able to host in-person events) as part of our annual Employee Appreciation Week, March 28-April. This reception will be for all nominees who were recognized in 2021 in the areas of hope, trust, stability, or compassion, which are the pillars that we built the Be a Bengal program around. For more information on this program check out <u>Be A Bengal | Idaho State University (isu.edu)</u>. We will recognize the 4 winners and all nominees at this reception. To assist us with choosing the 4 top winners out of all of the nominees for 2021, we are creating a committee consisting of faculty, staff, and student body representatives. The Lookout Credit Union sponsors this program each year, enabling us to provide \$25 gift cards for the monthly winners, providing support of the reception by providing the refreshments, and helping us put together 4 amazing baskets for the 2021 winners. We also have President Satterlee announcing the winners, either in person at the reception or in a pre-recorded video announcement of the winners to share with all of ISU.
