### 13) Letter Read to Faculty Senate by Dustin McNulty during Open Forum:

"Dear President Satterlee.

I am a professor within the ISU COSE Physics Program. I came to ISU in August 2010 as an assistant professor and this past summer was promoted to professor. I've been here a fairly long time and care deeply about the university, students, and community. My record of commitment to the university mission stands on its own -- I've graduated 2 PhD's and 3 MS's, worked with dozens of undergrads, and currently have \$1.3M in external grant awards over the next 3 years. I am writing this letter to communicate a grave situation that is effectively killing the fundamental science core of our university. The latest act of dismantlement of the COSE Physics unit is set to be a complete and permanent displacement of the physics program office (chair's office, admin assistant, files, records, dissertations, etc.) to a rumored-to-be, disparagingly small and inadequate hall corridor room. This is just the latest assault on what is now the only non-department entity in the university, COSE Physics. Since 2016, we have been systematically stripped of: department status, our chair position (no "real" leadership for over 5 years), and our only junior tenor-track faculty member (terminated in 2020 at the end of his 2nd year—with questionable justification). Good faculty members have left ISU Physics and they have not been replaced. There are now 5 faculty in ISU Physics (I am the newest hire of the bunch). This is less than half of our ranks from 2011, and yet our numbers of undergraduate and graduate degrees awarded are "hanging-on" competitively with comparable universities--most of which now have twice as many tenured/tenure-track physics faculty compared to ISU. Ten years ago, we had cumulative external awards that routinely totaled over \$5M/year. We have the Idaho Accelerator Center (on campus) -- one



of the top low energy accelerator facilities in the Western US; we have INL up the road. We have the potential to regain the research prominence that we've lost and grow our undergraduate enterprise if only given some minor investment. ISU Physics is suffering the same decline trends as COSE and the university have suffered since the failure of our international student initiative (and even before then). But Physics is not supported here, and I do not know why? Sorry to say this, but it is hard to find Trust, Compassion, and Stability in Physics at ISU and our last holdout, Hope, is now fading fast. Our grad student spaces have now been taken from us and all our students will be sent to the basement beamlab area (needing renovation of a laboratory space to make office space). While most of us have not been asked to move offices, our admin assistant will move to another building. The Dean's office will renovate and move into our admin space and remove our mail/coffee/printer/office supply room as well as free use of our conference room. There has been little communication from leadership regarding our impending displacement. This move will cripple our admin functions, recruitment, and so on. This latest assault on Physics shows that neither the College, nor perhaps the University, wants to try to help (at least) maintain a functional Physics program at ISU. ISU has been the clear leader in physics degrees awarded in our beloved state. This certainly cannot continue if we are effectively stripped of everything, including now our dignity (as educators, researchers, and human beings). Please intervene before it's too late. We need three things now: to be a department, a new (external) chair hire, and we cannot lose our administrative department space with no real plan for its future replacement (reckless). I request and welcome the opportunity to meet with you to further discuss these matters. I am not a trouble-maker. I write this letter whole-heartedly as my only hope to plead for some compassion towards Physics and to have more responsible change in COSE during our strategic planning initiative. Sincerely,
