- 5. REPRODUCTIONS will not be used in the promotion of a product or service for any purpose which implies the endorsement of the product, or service by IMNH without prior written consent.
- 6. This is not an exclusive privilege and IMNH reserves the right to make these same subjects or objects available to others.
- 7. The Applicant, in publishing said REPRODUCTIONS, assumes all liability and responsibility for any infringement of literary, copyright, or publication rights. The applicant indemnifies the Idaho Museum of Natural History, the State of Idaho, and Idaho State University from any claim brought by any third party based upon infringement of the preceding rights.
